Responsibilities

Broking Accounts (IBA)

- Maintain client and insurer/reinsurer ledgers; process premium bookings, brokerage recognition, endorsements, and return premiums accurately.
- Manage premium collection and allocation, statements of account, and timely settlement/remittance to insurers and reinsurers — including foreign currency remittances and supporting documentation for regulatory approval.
- Perform monthly reconciliations of client money/premium accounts, insurer/reinsurer balances, and bank accounts; investigate and clear aged items.
- Support credit control: ageing analysis, follow-up schedules, and escalation of overdue balances.

Financial & Regulatory Reporting

- Prepare monthly management accounts, cash-flow forecasts and budget-vs-actual analysis for both companies.
- Prepare TIRA statutory returns and other regulatory filings accurately and on time; support TRA compliance (VAT, WHT, corporate tax, payroll statutory deductions).
- Prepare year-end financial statements under IFRS and manage the external audit process.

Controls & Systems

- Maintain robust internal controls over client money, payments and payroll; document accounting procedures.
- Improve accounting systems and automation; safeguard data integrity between broking production records and the general ledger.

Education & Qualifications

- 5+ years accounting experience, including 2+ years in an insurance or reinsurance broking environment (IBA / client money / premium accounting)
